

TERMS OF SERVICE AND END USER LICENSE AGREEMENT (“EULA”)

The following terms of service and end user license agreement constitute an agreement between you and Spinstreak.com, and its affiliates (“*Spinstreak*”). This EULA governs your use of Software and Services (as specified below).

For purposes of this EULA "*Software*" means all software programs made available by Spinstreak including, but not limited to mobile applications, downloadable/installable applications for personal computer, and applications accessed by means of a browser or other online communication method. Software also includes updates and upgrades as well as accompanying manual(s), packaging and other written, files, electronic or on-line materials or documentation, and any and all copies of such software and its materials. "*Services*" means all services made available by Spinstreak, including but not limited to services accessed through mobile applications, by means of a browser or by other online communication method. Software and Services are collectively referred to as "*Spinstreak Services*".

THE SOFTWARE IS LICENSED, NOT SOLD. YOUR USE OF THE SOFTWARE (AS SPECIFIED BELOW) IS SUBJECT TO THE TERMS AND CONDITIONS SET FORTH IN THIS EULA. BY INSTALLING, USING OR ACCESSING THE SPINSTREAK SERVICES OR ANY MATERIALS INCLUDED IN OR WITH THE SPINSTREAK SERVICES, YOU HEREBY ACCEPT THE TERMS OF THIS EULA. IF YOU DO NOT ACCEPT THE TERMS OF THIS EULA, DO NOT INSTALL, USE OR ACCESS THE SPINSTREAK SERVICES.

1. LICENSES.

1.1. Software License.

Subject to this EULA and its terms and conditions, Spinstreak hereby grants you a non-exclusive, non-transferable, non-sublicensable, limited right and license to use one copy of the Software for your personal non-commercial use on a single computer or processing unit, unless otherwise specified in the Software documentation. The rights granted herein are subject to your compliance with this EULA. The Software is being licensed to you and you hereby acknowledge that no title or ownership in the Software is being transferred or assigned and this EULA is not to be construed as a sale of any rights in the Software.

1.2. Service License.

Subject to this EULA and its terms and conditions, Spinstreak hereby grants you a non-exclusive, non-transferable, non-sublicensable, limited right and license to use the Services as provided by Spinstreak, for your personal non-commercial use, in the manner permitted by this EULA. The rights granted herein are subject to your compliance with this EULA.

1.3. License Term.

The term of your licenses under this EULA shall commence on the date that you accept this EULA and install or otherwise use the Software and/or Services and ends on the earlier date of either your disposal of the Software and/or Services or Spinstreak's termination of this EULA. Your license terminates immediately if you attempt to circumvent any technical protection measures used in connection with the Software and/or Services or you otherwise use the Software and/or Services in breach of the terms of this EULA.

1.4. OWNERSHIP; NO OTHER LICENSES.

Spinstreak retains all right, title and interest in and to the Spinstreak Services, including, but not limited to, all copyrights, trademarks, trade secrets, trade names, proprietary rights, patents, titles, computer codes, audiovisual effects, themes, characters, character names, stories, dialog, settings, artwork, sound effects, musical works, and moral rights whether registered or not and all applications thereof. The Spinstreak Services are protected by applicable laws and treaties throughout the world. Unless expressly authorized by mandatory legislation, the Spinstreak Services may not be copied, reproduced or distributed in any manner or medium, in whole or in part, without prior written consent from Spinstreak. All rights not expressly granted to you herein are reserved by Spinstreak.

1.5. GENERAL LICENSE CONDITIONS.

You agree not to: (i) commercially exploit the Spinstreak Services; (ii) distribute, lease, license, sell, rent, lend, convey or otherwise transfer or assign the Spinstreak Services, any copies thereof, or any passwords or usernames of Spinstreak Services, without the express prior written consent of Spinstreak or as set forth in this EULA; (iii) make a copy of the Spinstreak Services or any part thereof, including but not limited to Software (other than as set forth herein); (iv) make the Spinstreak Services publicly available or available on a network for use or download by multiple users; (v) except as otherwise specifically provided by the Spinstreak Services or this EULA, use or install the Spinstreak Services (or permit others to do same) on a network, for on-line use, or on more than one computer or processing unit at the same time; (vi) reverse engineer, decompile, disassemble, translate, prepare derivative works based on or otherwise modify the Spinstreak Services, in whole or in part; (vii) remove, obscure or modify any copyright, trademark or other proprietary rights notices, marks or labels contained on or within the Spinstreak Services, falsify or delete any author attributions, legal notices or other labels of the origin or source of the material; (viii) misrepresent the source of ownership of the Spinstreak Services; (ix) transport, export or re-export (directly or indirectly) into any country forbidden to receive such Spinstreak Services by any U.S. or other export laws or accompanying regulations or otherwise violate such laws or regulations, that may be amended from time to time; or (x) scrape, build databases or otherwise create permanent copies of content returned from the Spinstreak Services.

The Spinstreak Services may include measures to control access to the Spinstreak Service, prevent unauthorized copies, or otherwise attempt to prevent anyone from exceeding the limited rights and licenses granted under this EULA. Only Spinstreak Services subject to a valid license

can be used to access online services, and download updates and patches. You may not interfere with such access control measures or attempt to disable or circumvent such security features. If you disable or otherwise tamper with the technical protection measures, the Spinstreak Services will not function properly.

The Spinstreak Services may allow you to create content. In exchange for use of the Spinstreak Services, and to the extent that your contributions through use of the Spinstreak Services give rise to any copyright, design right or any other intellectual or industrial property right you hereby grant Spinstreak an exclusive, royalty-free, perpetual, irrevocable, fully transferable and sub-licensable worldwide right and license to use your contributions in any way and for any purpose including, but not limited to the rights to reproduce, copy, adapt, modify, perform, display, publish, broadcast, transmit, or otherwise communicate to the public by any means whether now known or unknown and distribute your contributions without any further notice or compensation to you of any kind for the whole duration of protection granted to intellectual and industrial property rights by applicable laws and international conventions. If not expressly prohibited by mandatory legislation, you hereby waive any moral rights with respect to Spinstreak's and other players' use and enjoyment of such assets in connection with the Spinstreak Services and related goods and services under applicable law. This license grant to Spinstreak, and the above waiver of any applicable moral rights, survives any termination of this EULA.

The Spinstreak Services may require an internet connection to access the Spinstreak Services or its internet-based features, authenticate the Software, or perform other functions. In order for certain features of the Spinstreak Services to operate properly, you may be required to have and maintain (a) an adequate internet connection and/or (b) a valid and active account with an online service as set forth in the documentation related to Spinstreak Services. By using the Spinstreak Services, you acknowledge and agree that third party data transfer fees may apply depending on your data plan. Please consult your carrier for further information. If you do not maintain such accounts, then the Spinstreak Services or certain features of the Spinstreak Services may not operate or may cease to function properly, either in whole or in part.

2. INFORMATION COLLECTION AND USE; PRIVACY POLICY

By installing, accessing or using the Spinstreak Services, you consent to these information collection and usage terms, including (where applicable) the transfer of data into a country outside of the United States of America.

Spinstreak respects your privacy rights and recognizes the importance of protecting any information collected about you. Spinstreak's privacy policy as amended from time to time is available at www.Spinstreak.com/privacy ("*Privacy Policy*") and applicable to this EULA. Spinstreak's Privacy Policy defines how, why and to which extent Spinstreak collects and uses personal and non-personal information in relation to Spinstreak's products and services. By installing, accessing or using the Spinstreak Services you explicitly agree with the terms and conditions of Spinstreak's Privacy Policy and to any terms and conditions included therein by reference.

3. WARRANTY

3.1. Warranty for Physical software Products

Spinstreak warrants to you (if you are the initial and original purchaser of the Software) that, to the extent the Software is made available to you on a physical storage medium, the original storage medium holding the Software is free from defects in material and workmanship under normal use and service for 90 days from the date of purchase. If mandatory legislation in your jurisdiction requires longer in excess to the aforementioned 90 days, the length of the warranty is amended accordingly. If for any reason you find a defect in the physical storage medium during the warranty period, Spinstreak agrees to replace, free of charge, any physical storage medium and related Software discovered to be defective within the warranty period as long as the Software is currently commercially distributed by Spinstreak. If the Software is no longer available, Spinstreak retains the right to substitute a similar piece of Software of equal or greater value. This warranty is limited to the physical storage medium and the Software as originally provided by Spinstreak and is not applicable to normal wear and tear. This warranty shall not be applicable and shall be void if the defect has arisen through abuse, mistreatment, or neglect. Any implied warranties prescribed by statute are expressly limited to the warranty period described above. When returning the Software subject to the limited warranty above, please send the original Software only to the Spinstreak address specified below and include: your name and return address; a photocopy of your dated sales receipt; and a brief note describing the defect and the system on which you are running the Software.

3.2. No other Warranties

NOTWITHSTANDING THE ABOVEMENTIONED WARRANTY FOR PHYSICAL STORAGE MEDIUM SPECIFIED IN SECTION 3.1, ABOVE, AND TO THE FULLEST EXTENT PERMISSIBLE UNDER APPLICABLE LAW, THE SPINSTREAK SERVICES ARE PROVIDED TO YOU "AS IS," WITH ALL FAULTS, WITHOUT WARRANTY OF ANY KIND, WITHOUT PERFORMANCE ASSURANCES OR GUARANTEES OF ANY KIND, AND YOUR USE IS AT YOUR SOLE RISK. THE ENTIRE RISK OF SATISFACTORY QUALITY AND PERFORMANCE RESIDES WITH YOU. SPINSTREAK, SPINSTREAK'S LICENSORS AND CHANNEL PARTNERS DO NOT MAKE, AND HEREBY DISCLAIM, ANY AND ALL EXPRESS, IMPLIED OR STATUTORY WARRANTIES, INCLUDING IMPLIED WARRANTIES OF CONDITION, UNINTERRUPTED USE, ACCURACY OF DATA (INCLUDING BUT NOT LIMITED TO LOCATION DATA), MERCHANTABILITY, SATISFACTORY QUALITY, FITNESS FOR A PARTICULAR PURPOSE, NONINFRINGEMENT OF THIRD PARTY RIGHTS, AND WARRANTIES (IF ANY) ARISING FROM A COURSE OF DEALING, USAGE, OR TRADE PRACTICE. SPINSTREAK, SPINSTREAK'S LICENSORS AND CHANNEL PARTNERS DO NOT WARRANT AGAINST INTERFERENCE WITH YOUR ENJOYMENT OF THE SOFTWARE; THAT THE SPINSTREAK SERVICES WILL MEET YOUR REQUIREMENTS; THAT OPERATION OF THE SPINSTREAK SERVICES WILL BE UNINTERRUPTED OR ERROR-FREE, OR THAT THE SPINSTREAK SERVICES WILL INTEROPERATE OR BE

COMPATIBLE WITH ANY OTHER SPINSTREAK SERVICES OR THAT ANY ERRORS IN THE SPINSTREAK SERVICES WILL BE CORRECTED. NO ORAL OR WRITTEN ADVICE PROVIDED BY SPINSTREAK, SPINSTREAK'S LICENSORS AND CHANNEL PARTNERS OR ANY AUTHORIZED REPRESENTATIVE SHALL CREATE A WARRANTY. SOME JURISDICTIONS DO NOT ALLOW THE EXCLUSION OF OR LIMITATIONS ON IMPLIED WARRANTIES OR THE LIMITATIONS ON THE APPLICABLE STATUTORY RIGHTS OF A CONSUMER, SO SOME OR ALL OF THE ABOVE EXCLUSIONS AND LIMITATIONS APPLY ONLY TO THE FULLEST EXTENT PERMITTED BY LAW IN THE APPLICABLE JURISDICTION.

4. LIMITATION OF LIABILITY

IN NO EVENT WILL SPINSTREAK, SPINSTREAK'S LICENSORS OR CHANNEL PARTNERS BE LIABLE FOR SPECIAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES RESULTING FROM POSSESSION, ACCESS, USE OR MALFUNCTION OF THE SPINSTREAK SERVICES, INCLUDING BUT NOT LIMITED TO, DAMAGES TO PROPERTY, LOSS OF GOODWILL, COMPUTER FAILURE OR MALFUNCTION AND, TO THE EXTENT PERMITTED BY LAW, DAMAGES FOR PERSONAL INJURIES, PROPERTY DAMAGE, LOST PROFITS OR PUNITIVE DAMAGES FROM ANY CAUSES OF ACTION ARISING OUT OF OR RELATED TO THIS EULA OR THE SOFTWARE, WHETHER ARISING IN TORT (INCLUDING NEGLIGENCE), CONTRACT, STRICT LIABILITY OR OTHERWISE AND WHETHER OR NOT SPINSTREAK, SPINSTREAK'S LICENSORS OR CHANNEL PARTNERS HAVE BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. FOR PURPOSES OF THIS SECTION 5, SPINSTREAK'S LICENSORS AND CHANNEL PARTNERS ARE THIRD PARTY BENEFICIARIES TO THE LIMITATIONS OF LIABILITY SPECIFIED HEREIN AND THEY MAY ENFORCE THIS EULA AGAINST YOU. BECAUSE SOME STATES/COUNTRIES DO NOT ALLOW CERTAIN LIMITATIONS OF LIABILITY, THIS LIMITATION OF LIABILITY SHALL APPLY TO THE FULLEST EXTENT PERMITTED BY LAW IN THE APPLICABLE JURISDICTION. THIS LIMITATION OF LIABILITY SHALL NOT BE APPLICABLE SOLELY TO THE EXTENT THAT ANY SPECIFIC PROVISION OF THIS LIMITATION OF LIABILITY IS PROHIBITED BY ANY FEDERAL, STATE, OR MUNICIPAL LAW, WHICH CANNOT BE PRE-EMPTED. THIS EULA GIVES YOU SPECIFIC LEGAL RIGHTS, AND YOU MAY HAVE OTHER RIGHTS THAT VARY FROM JURISDICTION TO JURISDICTION.

IN NO EVENT SHALL SPINSTREAK'S, SPINSTREAK'S LICENSORS' OR CHANNEL PARTNERS' LIABILITY FOR ALL DAMAGES (EXCEPT AS REQUIRED BY APPLICABLE LAW) EXCEED THE ACTUAL PRICE PAID BY YOU FOR USE OF THE SOFTWARE OR FIVE DOLLARS, WHICHEVER LESS.

5. TERMINATION; REMEDIES

This EULA will terminate automatically if you fail to comply with its terms and conditions. In such event, you must destroy all copies of the Software and all of its component parts and cease and desist from accessing any Spinstreak Services. With regards to Software delivered on a physical storage medium you can end this EULA by destroying the Software and all copies and reproductions of the Software and deleting and permanently purging the Software from any client server or computer on which it has been installed. You hereby agree that if the terms of this EULA are not specifically observed, Spinstreak will be irreparably damaged, and therefore you agree that Spinstreak shall be entitled, without bond, other security or proof of damages, to appropriate equitable remedies with respect to your breach of any of the terms of this EULA, in addition to any other available remedies.

6. INDEMNITY

You agree to indemnify, defend and hold Spinstreak, its partners, affiliates, contractors, officers, directors, employees and agents harmless from and against any and all damages, losses and expenses arising directly or indirectly from: (i) your acts and omissions to act in using the Spinstreak Services pursuant to the terms of the EULA; or (ii) your breach of this EULA.

7. GOVERNING LAW AND DISPUTE RESOLUTION

This EULA will be governed by the laws of the State of Missouri, United States of America, without reference to its choice of law rules. The United Nations Convention for the International Sale of Goods shall not apply. Any dispute, controversy or claim arising out of or relating to this EULA or the breach, termination or validity thereof shall be determined by binding arbitration administered by the American Arbitration Association in accordance with its Commercial Arbitration Rules. The place of the arbitration shall be St. Louis, Missouri, United States of America. The language of the arbitration shall be English. YOU AGREE THAT YOU MAY BRING CLAIMS AGAINST SPINSTREAK ONLY IN YOUR INDIVIDUAL CAPACITY AND NOT AS A PLAINTIFF OR CLASS MEMBER IN ANY PURPORTED CLASS OR REPRESENTATIVE PROCEEDING.

8. MISCELLANEOUS.

This EULA represents the complete agreement concerning this license between the parties and supersedes all prior agreements and representations between them. It may be amended only by a written document executed by both parties. If any provision of this EULA is held to be unenforceable for any reason, such provision shall be reformed only to the extent necessary to make it enforceable and the remaining provisions of this EULA shall not be affected.
